Be it remembered, that Harry Schussler then residing at Chase City, State Territory of Virginia, who previous to his naturalization was a subject of Austria-Hungary, having applied to be admitted a citizen of the United States of America pursuant to law, and at a Regular term of the District Court of United States, held at Richmond, on the 14 day of January, in the year of our Lord nineteen hundred and twenty, the court having found that the petitioner had resided continuously within the United States for at least five years and in this State Territory for at least one year immediately preceding the date of the filing of his petition, and that said petitioner intends to reside permanently in the United States, had in all respects complied with the law in relation thereto, and that he was entitled to be so admitted, it was thereupon ordered by the said court that he be admitted as a citizen of the United States of America.

In testimony whereof the seal of said court is hereto affixed on the 14 day of January, in the year of our Lord nineteen hundred and twenty, and of our Independence the one hundred and forty fourth year.
